#### June, 2023 Of flowers, furrows, and funding

Earlier this week, I turned the corner from the garage to the front door and was greeted by the opening buds of the columbines I planted a couple years ago. No matter how often I've seen this happen, it still seems magical when what was bare ground just a couple weeks ago produces such gloriously delicate blooms. It makes me anxious to see how all the newly furrowed fields will start producing the abundant harvests that characterize our beautiful area.

Last month I shared that Shelburne received a Municipal Vulnerability Preparedness (MVP) Planning Grant from the Massachusetts

Executive Office of Energy & Environmental Affairs. The planning process is a requirement for being designated a Certified MVP Community, which opens up myriad funding opportunities. The Selectboard has agreed on the consultant and, as of this writing, awaits finalization of the contract. Pending no delays, meetings with a core group of diverse stakeholders will start later this month. In my capacity as the Town Liaison to the MVP project, my goals are to keep the project **on track**, keep you **informed** of progress, and ensure that the planning process involves a **wide spectrum** of participants. We will convene a **public listening session** in the fall (currently targeted for November) to allow for the incorporation of townspeople's feedback in the final plan. ### Town Hall News

Here are this month's updates on the Bridge Street construction project.

### Water and Sewer System improvements are complete!

**Paving.** The road surface will be reclaimed, graded, and a new layer of pavement laid after



the new water system has been installed and the temporary water bypass has been removed. (Final road surface paving will occur in the fall.)

Projected Start Date: Week of May 30. Sidewalks. New sidewalk construction will



begin a section at a time, removing and pouring the sidewalk just in that section. The contractor has been instructed to maintain building access at all times and

will install temporary ramps to building entrances.

Projected Start: Week of June 5. Target Completion Date: July 15.

**Trees.** The two Honey Locust trees in front of Greenfield Savings Bank will be **relocated** and



still **need a home**. Anyone interested in having a tree planted along their tree belt should <u>contact Town Administrator</u> Terry Narkewicz at (413) 625-0300, X1. Traffic and parking changes during construction. Pedestrian traffic will be accommodated to ensure that patrons have safe access to local businesses. Police details will be used to control traffic, as directed by the Police Chief. There will be **limited parking** in the project area on the north side of Bridge Street during water line work. Sidewalk construction will also **temporarily eliminate parking** in the section of sidewalk where work is occurring. Paving will require that traffic be **detoured**.

#### Specialized help in an emergency

Shelburne Fire Chief John Taylor alerts us to the availability of another service that can provide specialized help to people with a disability. The **Massachusetts Disability Indicator Program** offers a **free, voluntary service** that alerts 9-1-1 personnel that an individual with a disability may have unique safety, communications or other needs in case of an emergency.

This service was developed in consultation with organizations representing the mobility, hearing, speech and sight impaired communities, and is **available for landline**, **wireless, and VoIP telephone service** providers. The information provided will remain **confidential** and will ONLY appear on the dispatcher's screen when a 9-1-1 call originates from the phone number(s) provided.




Image: DIsability Indicator Form from Mass.gov

## Boards & Committees

#### **AGRICULTURAL COMMISSION**

Chair Carolyn Wheeler shares that the Shelburne Agricultural Commission met on April 27 at the Shelburne Center Fire Station to see a presentation by USDA Certified Professional Soil Scientist Albert Averill (albert.averill@usda.gov) of the American Farmland Trust. Averill provided a presentation about Farmland of Local Importance and announced that the Town of Shelburne and the USDA's Natural Resources Conservation Service (NRCS) have recognized farmland of local importance in Shelburne. Farmland of local importance consists of soil types additional to prime farmland soils and farmland of statewide importance that are suited for crop production.

The NRCS works with landowners to improve and protect soil, water, and other natural resources. It also implements the **Agricultural Conservation Easement Program (ACEP)** which provides financial assistance to eligible partners for purchasing agricultural land easements from willing landowners. Eligibility for ACEP funding requires that the land consist of more than 50 percent important farmland soils. Now that Shelburne and NRCS have identified farmland of local importance, **more farmlands may be eligible for federal preservation funding.**

#### **BOARD OF HEALTH**

Members of the Shelburne Board of Health will hold a **public hearing** on Wednesday, June 14, 2023 at 9:30 am via Zoom to review and consider adopting updated **Marijuana Regulations** and newly created **Body Art Regulations**. #### **CPA COMMITTEE, ANYONE?**

The Town accepted the **Community Preservation Act** (CPA) bylaw at Town Meeting last month (Article 27 on the warrant) and it awaits approval by the Commonwealth Attorney General's office before it can be staffed. By statute, the Shelburne CPA **Committee** will consist of 5 required and 4 at-large members. Here's how that breaks down.

**Five required members,** one each from the following categories:

- Conservation Commission
- Planning Board
- Recreation Committee
- Town resident interested in historic preservation
- Town resident interested in affordable housing

#### Four members at Large, comprised of:

- One from the Open Space Committee
- One from the Agricultural Commission
- Two Town residents appointed by the Selectboard

Stay tuned here for **updates**, and in the meantime, think about **who would be a good committee member**!

#### **ENERGY COMMITTEE**

From Tom Johnson, Chair: The Shelburne Energy Committee (SEC) is investigating what options for **LED Street Light** conversion may be available for our town. Eversource has offered an interesting free installation of LED lights (now on display on Water, Church and Main Street).

We are interested to know if this is the most **cost-effective approach**. As a result, we are in correspondence with RealTerm Energy (RTE), a well-known and highly recommended street light consulting firm. RTE has provided a desk-top study that indicates how we can reduce our annual streetlight energy bill. Their approach appears to save even more than what has been offered by Eversource, using lights that may be healthier, more environmentally sound, and visually appealing. 
#### **OPEN SPACE COMMITTEE**

Jim Perry announces a **June 10 Guided Walk: Urban Trees of Shelburne Falls, MA.** The Shelburne Open Space Committee, Deerfield River Watershed Association, Shelburne Falls Senior Center, and Arms Library have partnered to lead a scenic and educational, 2-loop walk around downtown Shelburne Falls. Our plan is to learn about the local, urban trees, their identification, importance, and management issues, including diseases.

What to Bring: Hikers should wear comfortable walking sneakers, shoes, or

**boots** and bring **water** to drink, a **snack**, **hat**, and **sunscreen**, etc. Village Walking Tour maps will be provided.

What to Know: This walk is rated as "easy," but with uneven sidewalks, street crossings, etc. The walk is broken into two loops. The first loop, a shorter and flatter loop, will



cover the lower Shelburne Falls–Bridge Street Business District and some back streets, and will loop back to the Arms library for those walkers who do not want to walk a longer distance (maybe 1 hour).

For those who want to carry on farther, a **second loop** will proceed up Bridge Street from the Arms Library and tour some of the back, **more hilly** streets before

returning to the Arms Library (maybe add 45 minutes). Nothing too difficult is expected.

Where to Meet: Meet at the front steps of the Arms Library in Shelburne Falls at 9:00 AM on Saturday, June 10.

#### **PLANNING BOARD**

The **next meeting** of the Shelburne Planning Board is **June 6 at 6:30 pm**. Agendas with the Zoom link to meetings are posted at <u>https://townofshelburne.com/f/0/12/</u>

At the last meeting (on May 9), the Board met with FRCOG's Kimberly Noake MacPhee to discuss ways that **climate-resilient zoning changes** could protect water quality and river health. The board agreed to participate in her grant-funded **Watershed-Scale Zoning Project** which includes Shelburne, Greenfield, and Bernardston. The Board will meet again with MacPhee at our August meeting, rescheduled for **August 8**.

Speaking of schedules, the Planning Board's July meeting will be held on **July 11** due to the holiday.

The Board's **proposed bylaws passed** at Town Meeting (Articles 28 and 29), and await approval from the Attorney General's office. That part of the process has an unknown time frame, but once they are approved, the updated bylaws will be posted on the Town website. A member of our Planning Board also attends the bimonthly meetings of the Regional **Planning Board** for the Franklin Regional Council of Governments (FRCOG). The May meeting featured three speakers.

Planning Director Peggy Sloan briefly shared information about the FERC **Relicensing** agreement which included new investments and improvements for recreation. She will provide more details at a future meeting.

> Senior Land Use and Natural Resources Planner Allison Gage updated the Board on the **Clesson Brook Watershed Climate Resiliency**

**MVP Project** and announced a virtual Community Meeting to be held at 6-7:30 pm on June 7 to present final findings. <u>Register here</u> to attend the meeting over Zoom.



The bulk of the meeting revolved around the detailed presentation prepared by Economic Development Program Manager Jessica Atwood about the draft Comprehensive **Economic Development Strategy (CEDS)** Annual **Performance Report.** She noted that the draft is open for comments and questions until June

7, 2023. Here are a few **highlights**:

"Advancing strategies to retain and attract a younger and more diverse labor force is *imperative* to ensuring the future of Franklin County's vitality and economy." (p. 12)

Franklin County's **population** declined by 0.5% since 2010, but Massachusetts experienced a

population increase of 6.9% in the same period.



The county's unemployment rate decreased more than a point-and-a-half and remains below the state rate (3.4%

vs. 3.8% in 2022). The report warns, though, that how these rates are calculated "does not tell the entire story,...(and) changes to the number of people engaged in the labor force is also important."

> "Accommodations, like Shelburne Springs, are important to encourage visitors to extend their stay and **generate more** economic activity." (p. 26)

Atwood emphasized new **positive developments** in the area, including Shelburne's very own new boutique hotel on Route 2, and a state grant FRCOG received to evaluate downtown district management models in Shelburne Falls, Greenfield and Turners Falls and provide recommendations for their sustainability.

"Dynamic downtowns allow for **local**... *sustain(ability)*, which is a benefit to residents ... and (can) encourage people to move to the region." (p. 30)

## Emergency Management Director's Page

Greetings. **Thank you** all for voting in the \$5500 capital expense at our town meeting last month. This money will be used **to transfer the emergency management radios** from the fire station to the emergency operation center (EOC) at the Police Station/Municipal Building on the Mohawk Trail. It's the last step in getting our EOC fully operational. Thanks again.



Speaking of a fully operational EOC, what we need now are more trained volunteers to help operate it. If you'd like to learn how to **communicate with radios, gather incident information** and plot it on a map, and assist with **supporting emergency responders** in the field, then come join the emergency management operations team. This team will be called upon to **assist committee members** with various duties in the EOC in the event of an emergency. #### Here are the other projects the Emergency Management Committee is working on:

**Cooling/warming centers** where you can go when temperatures reach an extreme and you have no way to deal with them, such as the lack of air conditioning or heat due to a power outage.

Improvements to the town's emergency alert system. This system is subscriber-based, one that asks residents to sign up to receive text messages warning of coming emergency events and during them. For example, during the March snowstorm, messages may have been sent notifying you that Route 2 was blocked due to a fallen tree or that a warming center had just been opened. This communication system will be used for emergency events only. As you know, communications during an emergency event are critical.

#### **CHAINSAW SAFETY WORKSHOP**

Gregory Cox, Program Director of the Massachusetts Forest Alliance announces that the Massachusetts Forest Trust is holding **reduced-cost two-day Safe Chainsaw Operation workshops for landowners and Tree Farmers** in the Woodlands Partnership area of western Franklin and northern Berkshire counties. These hands-on workshops, which normally cost \$300 per person, will cost **just \$100** thanks to a grant from the Massachusetts Department of Conservation & Recreation.

Chainsaws are the most common tool used by landowners in managing and caring for their woods and trees. **Chainsaws are inherently dangerous** and proper maintenance and careful operation are necessary to avoid injuries or even death.

#### **SENATOR PAUL MARK**

After twelve years in the House of Representatives, Senator Paul Mark (Berkshire, Hampden, Franklin and Hampshire District) has completed his first Senate **budget** and is proud to announce



that Western Massachusetts has secured **significant allotments** for various programs.

In education, Sen. Mark secured an earmark to level the **Massachusetts College of Liberal Arts** with the rest of the state colleges, and included enough funding for an MCLA **diversity educator program**. He has also secured **\$15 Million for Rural School Aid**–a significant increase from both the Governor's and House's proposed amounts–and **\$25,000 to support the Mary Lyon Foundation**, which promotes student success in Shelburne and the other eight towns in the Mohawk Trail Regional School District.

Sen. Mark was able to **double the amount of funding for the Opioid Task Force** in the Berkshire Sheriff's Department. This funding will help ensure that there are more resources for individuals involved in educational efforts to encourage treatment and for those facing or seeking recovery from substance abuse. He also is proud to have secured a budget amendment of **\$75,000 for the Western Mass Network to End Homelessness** to support rapid response activities and crisis management in all four counties.
