### Josh Simpson – Solar Display

### 10 Water Street - Exempt Property Status

A representative joined the Board of Assessors to discuss the exempt status of the property. 1244 square feet is currently being rented to a business. It was confirmed that the organization does use the space for meetings and they donate the net income to several charities. A list was provided to the assessors of the donations for the last two years without monetary information. The board requested that they be provided with an updated list showing the amount of money donated to outside organizations.

## Lisa Goddard - Echo Art Gallery

Ms. Goddard joined the Board of Assessors to discuss the personal property tax assessed to her art gallery on Bridge Street. Ms. Goddard was given explanation of personal property tax<sup>8</sup> and the form of list. JM informed her that an inspector from Patriot Properties and the Board of Assessors would be out to inspect the property and could help her with the form of list. A form of list was not filed for Fiscal Year 2018 and Patriot Properties estimated the value of the property, Ms. Goddard did not appeal the tax by the February 1, 2018 deadline.

JM provided all members of the board with documentation they would need to support the Annual Town Meeting Warrant. Included in the packet was information on the Senior Exemption 41C, and Capital Requests for new motor vehicle software and cyclical inspection completion.
