Land Influence Codes⁷ - Jenn inquired on the history of negative land influence codes for parcels. While working on chapter a negative influence for a land locked parcel of chapter was noticed. The three parcels with land locked influence codes were no longer land locked and the board agreed to remove the influence from these parcels. Some of the land influence codes and percentages did not seem to be consistent and will need to be reviewed further after Jenn obtains guidance from DOR on land influence codes. Jenn shared a conversation with Patriot Properties regarding the recent sales in the Patten Hill area that are increasing the land values in that neighborhood. Discussion regarding positive land influences or a view tax.
