The meeting was called to order at 6:30 pm.

Motion to recess the Board of Health meeting to convene a public hearing relative to proposed regulations "To Ensure the Sanitary and Safe Operation of Marijuana Establishments and the Sale of Marijuana" was made by Bob and seconded by Rob.

Vote: 3 in favor, 0 opposed, 0 abstentions.

The Public Hearing relative To Ensure the Sanitary and Safe Operation of Marijuana Establishments and the Sale of Marijuana was called to order at 6:44 pm.

Deb reviewed the purpose of the hearing and the handouts: a copy of the proposed regulations with possible revisions in bold typeface, a copy of the Adult-Use Marijuana Establishments recently adopted zoning bylaw definitions and use table, and a map showing a 500 foot setback from the Buckland Shelburne Elementary School and a preschool on Water St.

Review of Public Hearing: it was noted that no public comments had been received even though the meeting had been duly posted.

Adult-Use Marijuana Health Regulations – the consensus of the Board was to incorporate all revisions they had developed that had revised the model regulation to meet the needs of the Town of Shelburne. All of these modifications had been included in the materials distributed during the public hearing.

A Motion to adopt the Town of Shelburne "Regulation" to Ensure the Sanitary and Safe Operation of Marijuana Establishments and the Sale of Marijuana" effective immediately as revised was made by Bob and seconded by Rob. Vore: 3 in favor, 0 opposed, 0 abstentions.

The Board noted that they were to pleased to have adopted these regulations before the Town's zoning moratorium was due to end on June 30th.
