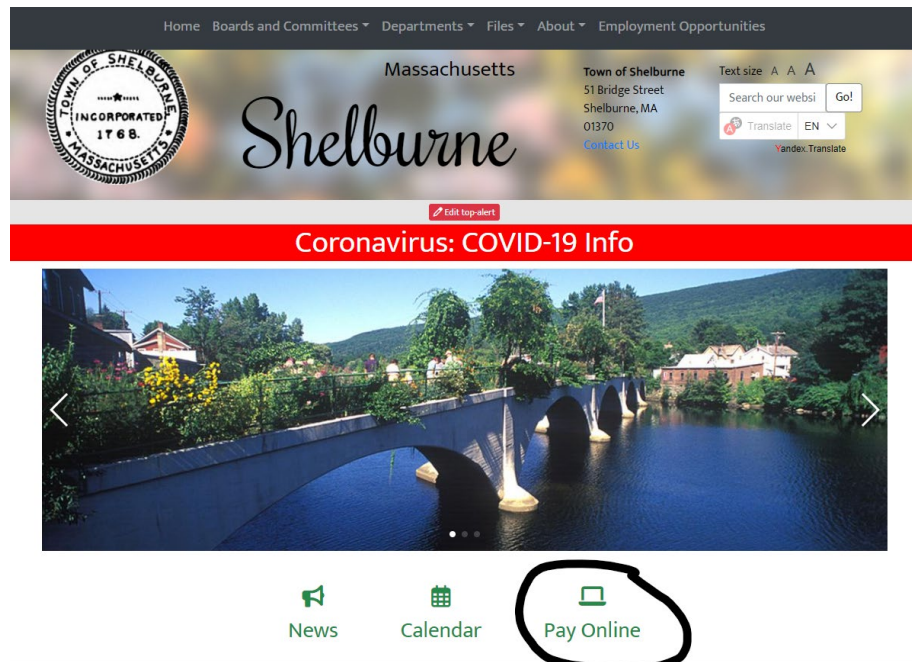


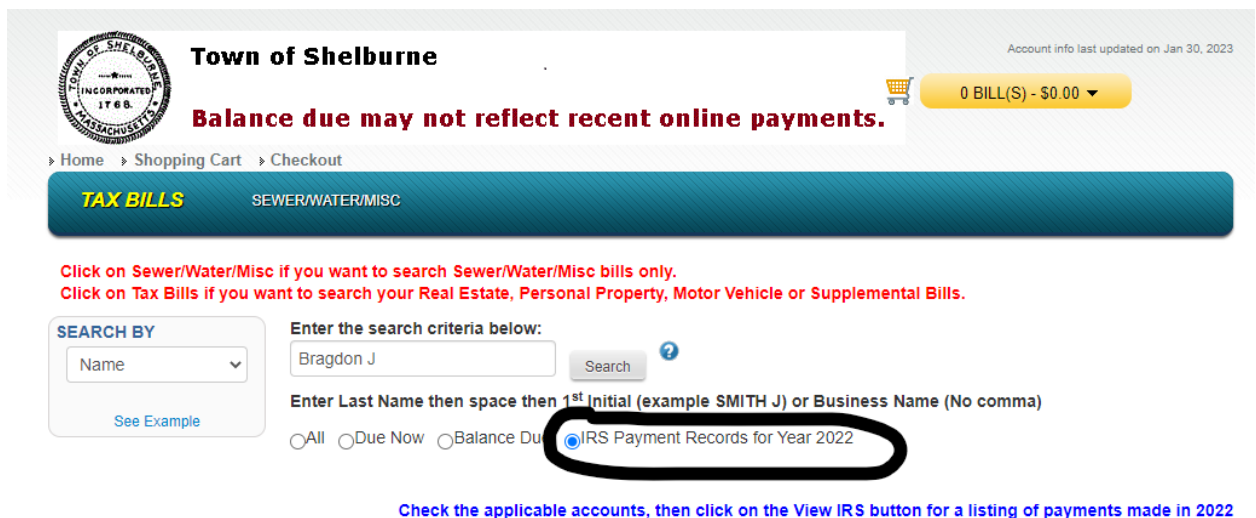
# How to Get Your Real Estate Tax Information for Filing Your Taxes

How to get the amount you paid in 2022 for filing your taxes.

1. Go to the town's website <https://townofshelburne.com/>
2. Click on the pay online link. This will open a new tab.













3. Easiest way to find your property is by searching for your name. You will want to put your last name in first in the search bar. Once you do that you will want to pick the option for "IRS Payment Records for Year 2022." Then click search.

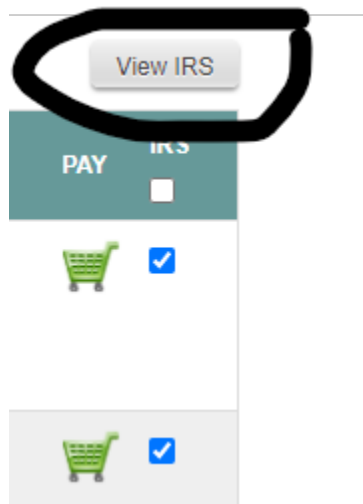


# How to Get Your Real Estate Tax Information for Filing Your Taxes

- This will bring up a list of all the bills you paid for in calendar year 2022. To the far right there is a column "IRS" This is where you can select all by clicking the box right under IRS or you can select bills individually.
